

Challenge

Similar to most letting agents in the UK, Martyn Gerrard were experiencing difficulties tracking, signing and getting documentation returned, such as tenancy agreements and contracts. The turnaround time for these ranged from a few days to a couple of weeks, which slowed the process and could often lead to disgruntled landlords and tenants or the property being taken by another tenant.

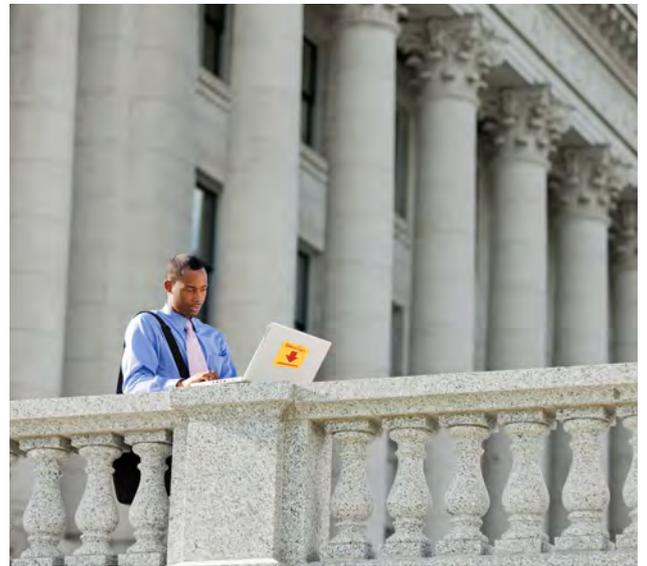
The Key Benefits

This again meant that agreements could be exchanged in a couple of days--and often just a few hours--compared to weeks for paper documentation.

DocuSign has also given Martyn Gerrard the competitive edge and in at least five occasions; DocuSign has allowed Martyn Gerrard to beat a competitor to a successful let. This is due to the speed in which they were able to have all the necessary paperwork signed and returned compared to the previous method. While other agents are waiting signed terms from the landlord, Martyn Gerrard clients have received T & C's via DocuSign, and given a holding deposit, while other agents were still waiting for the return of the landlord's authority to proceed.
